- 52 RBOs filed Compliance Statements


#### Monthly:

5 RBOs file monthly financial statements






#### Status of all Risk Bearing Organizations




# Top 20 RBOs with Greater than 50% Estimated Medi-Cal Lives








### Remaining RBOs with Medi-Cal Lives
